


## Overview

## Assessing Vulnerability

- Pre-defined methodology small deviations allowed
- Includes sea-level rise and precipitation modeling
- Broad definition of assets
- Quantitative and qualitative impact analysis

Assets are features within a community that the region values. Identified assets can include facilities, populations, processes, services, functions, institutions, or networks that are essential to day-to-day life, rapid disaster recovery, and long-term resilience of the community. They are the places, people, events, processes, and things that define your community.

- Potential ideas: funding applications, concept drawings, master plan or ordinance updates






