In prior roles, Alex has worked towards 'energy democracy' and fair access to the benefits of energy efficiency programs, clean local energy infrastructure through "community microgrids," and a robust green economy that empowers communities at the frontlines of climate disruption and systemic inequities. At CED, he supports municipal innovations like participatory budgeting, statewide worker-ownership infrastructure and federal-level interventions to ensure community control of new investments and democratic governance.

A perpetual student at the University of Life, Alex is actively plotting his next adventure off the grid.

Lauren Sampson is a Staff Attorney with Lawyers for Civil Rights, an impact litigation, racial justice nonprofit headquartered in Boston. Lauren advances LCR's life-changing and law-changing work through litigation, policy advocacy, and community education. Lauren is currently litigating *Massachusetts Fair Housing Center v. HUD*, the first lawsuit nationally challenging the Trump Administration's attempt to gut the disparate impact protections of the Fair Housing Act. In 2020, she secured a landmark <u>nationwide preliminary injunction</u> blocking the Trump Administration from implementing changes to the Fair Housing Act. Recently, she also successfully litigated <u>Mussotte v. Peyser</u>, a groundbreaking challenge to Massachusetts' school funding formula on behalf of children of color and low-income children. Her cutting-edge work is regularly featured in publications such as the *New York Times*.

Lauren coordinates LCR's <u>Racial Justice & Climate Project</u>, a new practice area focusing on climate resilience and environmental justice in low-income communities of color and immigrant communities. Under her leadership, the initiative recently filed a major federal lawsuit against the EPA for failing to investigate and address national origin discrimination — along with a series of high-profile <u>language</u> <u>access</u> complaints against proposed environmentally-sensitive projects in Boston.

Lauren currently serves as the Vice Chair of the Board of Directors of Boston CASA (Court Appointed Special Advocates), which advocates on behalf of court-involved children, and on the Board of Directors for the Welcome Project, a community-based immigrants' rights organization. She also serves on the Steering Committee for the Climate Adaptation Forum and the Advisory Board of Alternatives for Community & Environment's (ACE) environmental justice legal services program.

Lauren is a *magna cum laude* graduate of Duke University School of Law, where she was elected to the Order of the Coif, and served as the editor-in-chief of the Duke Journal of Gender Law and Policy. She also holds a Master's degree in English Literature from Duke. She is a member of the bars of New York and Massachusetts.

Oscar A. Chacón is a co-founder and executive director of Alianza Americas, a Chicago-based national network of Latin American immigrant-led and immigrant serving organizations in the US. Oscar is an immigrant from El Salvador. He has been an organizer and a leader on community justice issues at the local, national and international levels for over 30 years. He has occupied leadership positions in multiple organizations including Oxfam America, Centro Presente, the Northern California Coalition for

Immigrant and Refugee Rights, and Heartland Alliance for Human Needs and Human Rights. Oscar is a member of the Inter-American Dialogue, the American Bar Association's Immigration Commission and the Latino-Jewish Leadership Council, among other professional associations. Oscar is a frequent spokesperson, domestically and internationally, on economic, social, political and cultural issues affecting Latin American immigrant communities, including the nexus between human mobility, economic inequality, white supremacy and racial justice. Alianza Americas mission is to improve the quality of life of Latin American immigrant communities in the US, as well as of peoples throughout the Americas.
